






# **Available Funding**



2025 **Community Events Grant Program** 



#### (Base Grant)

to assist eligible event organisers to ensure inclusive Australia Day 2025 events proceed

#### \$5,000.00

#### (Additional Grant)

for events that include significant Aboriginal and/or **Torres Strait** Islander elements

### (Total Pool)

Successful applicants may only receive one grant (Base only **or** Base + Additional)

# Eligibility



Australian local government entities



Australian state or territory government entities

Australian not-for-profit organisations

- public liability insurance of not less than \$10 million
- planned event should include an inclusivity element for people with disability

# **Inclusivity and Accessibility**



 Applicants are encouraged to consult the <u>Australian Human</u> <u>Rights Commission guidelines</u> by *IncludeAbility* on how to hold an accessible and inclusive event

### Accessibility costs can be covered under grant funding

- hire of ramps or other accessibility equipment
- Auslan interpretation
- live captioning services

### **Other Key Requirements**



2025 Community Events Grant Program

It is a condition of receiving a grant that the message of '**Reflect. Respect. Celebrate.'** is promoted through NADC-available collateral.

#### Successful applicants must:

- clearly use the Australia Day Designs in equal proportion to other branding and marketing used on the day
- ✓ display the Australia Day Designs at an event or in a public space
- ✓ use the Australia Day Designs in the lead-up to and on Australia Day 2025

### **Use of Grant Funds**



2025 Community Events Grant Program

### What we will fund

- promotions, invitations, publicity, communications
- artist and/or talent fees
- accessibility equipment and formats
- face-to-face event costs
- virtual event costs

### What we won't fund

- organisation's core operational expense costs
- purchase of assets or infrastructure (e.g., buildings, renovations, BBQs, facility upgrades)
- costs not clearly attributable to Australia Day 2025
- events by local, state or territory gov's with lower investment than 2024
- non-Australia Day focused events

- Australia Day Community Fair
- Australia Day Multicultural Festival
- Australia Day Concert
- Australia Day Picnic
- Smoking Ceremony / Welcome to Country/Acknowledgement
- Australia Day Flag Raising Ceremony
- Australia Day Citizenship Ceremony
- Barbecue in the Park / Street
- Community Fireworks

- Australia Day Parade
- Aussie Beach Party
- Australia Day Breakfast / Lunch
- Cultural Ceremony
  - Australia Day Race / Marathon
- Virtual event
- Digital content development for any of the above
- Australia Day event collateral (i.e. Australian symbols, banners, flags).

# **Additional Funding**



Applicants can apply for an **Additional Grant of \$5,000** to put toward any costs incurred to enable **significant Aboriginal and/or Torres Strait Islander elements** in Australia Day events

Note: a Welcome to Country, or Acknowledgment of, Country alone will <u>not</u> suffice

### Eligible examples include, but are not limited to:

- smoking ceremonies
- cultural walks
- indigenous foods and plants
- local Aboriginal &/or Torres Strait Islander speakers, musicians & artists
- art or crafts displays, murals and art projects
- celebration of culture through inclusion of language, music, storytelling, dance
- readings of historical documents

### What You Need to Do




### Before you begin, ensure to:

- **Read Guidelines:** review Grant Guidelines and Sample Agreement
- **Prepare Insurance:** have your public liability insurance (min. \$10M) ready
- Banking Details: have proof of your organisation's bank account
- Know Your Event: understand your event and the assessment criteria
- Additional Grant: (if applying) understand and be able to outline how you'll include significant Aboriginal/Torres Strait Islander elements

## **Successful Applicants**



#### 2025 Community Events Grant Program

#### **Grant Agreement**

Successful applicants will be required to enter into a short-form agreement with the NADC. Some aspects of the Grant Agreement will require applicants to:

- utilise the message of 'Reflect, Respect, Celebrate' in their event
- acknowledge NADC's support through use of the NADC's logo or signage
- acknowledge that the event may be listed on NADC's event register website
- acknowledge the return of any unused grant funds to NADC
- Submit the following by 30 April 2025: [1] **Final Report**, [2] photos of **applicant's materials** with Aus. day designs [3] **photos** of the event

### Payments

- 80% of the grant as an upfront payment
- 20% after receipt of final report
- final instalment within 20 days of approving the final report and receiving a correctly rendered invoice
